Emergency Clinicians provide assessments, crisis intervention, hospital diversion, pre-admission screening, as well as other services. Emergency services are provided by credentialed behavioral health and substance use disorder practitioners who are skilled in emergency assessment, crisis intervention and pre-admission screening. Emergency services are provided in the least restrictive manner possible to promote individual and community safety, consumer autonomy and access to behavioral health and substance use disorder services.
